The increasing international migration to multiple destinations has created new type of families which are often referred to as transnational families. A significant number urban middle class in India's metropolis have these types of families today. Though it is a growing area of research today, there are still dearth of research on this rising phenomenon.

Prof. Supriya Singh is one of the pioneers who carried out her research work on the care giving in the transnational families a decade back. She also extensively researched on how money plays an important role in transnational care giving. GRFDT in its monthly seminar series organized a talk on "Small business as a transnational family strategy: A focus on Indian migrants in Australia and Singapore". Talking on the issue, Prof. Singh argued that small business is important for Indian migrants in Australia and Singapore as a strategy for keeping the transnational family together.

GRFDT Seminar

Small Business as a Transnational family strategy *Indian diaspora in Australia and Singapore*

Global Research Forum on Diaspora and Transnationalism, its monthly seminar series organized a talk on “**Small business as a transnational family strategy: A focus on Indian migrants in Australia and Singapore**” by **Prof. Supriya Singh**, Professor, Sociology of Communications, RMIT University, Melbourne,

Australia at CSSS II, Jawaharlal Nehru University on 8th March 2014. The study was based on preliminary analysis of open-ended interviews between November 2013 and February 2014.

In her presentation Prof. Singh argued that small business is important for Indian migrants in Australia and Singapore as a

strategy for keeping the transnational family together. This is in addition to business being an avenue for employment and economic mobility while also being a strategy for return. The family aspects of small business come through in stories of starting a family business in Australia as a way of supporting a joint or extended family in Australia. Managing or starting a small business in India; considering the option of joining the family business; or operating a business in India as well as the country of destination are other ways of connecting the two parts of the transnational family. Out of 31 families

in the study, 16 families related to business strata, 7 doing business for mandatory return, 7 families doing business for economic mobility and remaining 7 families have not yet in business.

Prof. Singh also narrated the difficulties in conducting this study as it involves emotional aspects. Many do not



share their feeling and information easily. In the interactive session, Prof. Singh gave the composition of these small business communities in Australia in earlier were mainly from Marwadi, Punjabi and Gujaratis and in some cases jats and upper middle classes. However the composition of families doing small business has been changing in recent times with more lower middle classes coming in.

The seminar concluded with vote of thank from Dr. Mahalingam M., member of GRFDT.
